



## ReWalk Robotics Announces Pricing of \$11.6 Million Public Offering

YOKNEAM ILIT, ISRAEL and MARLBOROUGH, Mass., Nov. 16, 2018 (GLOBE NEWSWIRE) -- ReWalk Robotics Ltd. (Nasdaq: RWLK) ("ReWalk" or the "Company") today announced the pricing of an underwritten public offering of 38,660,722 units at a price to the public of \$0.30 per unit. Each unit contains one ordinary share (or ordinary share equivalent) and one common warrant to purchase one ordinary share. The ordinary shares (or ordinary share equivalents) and common warrants included in the units can only be purchased together in this offering, but will be issued separately and will be immediately separable upon issuance.

H.C. Wainwright & Co. is acting as lead book-running manager for the offering. ThinkEquity, a division of Fordham Financial Management, Inc., is acting as co-manager for the offering.

Each common warrant has an exercise price of \$0.30 per share, is exercisable immediately and will expire five years from the date of issuance.

In connection with the offering, ReWalk has granted the underwriters a 30-day option to purchase up to additional 5,799,108 ordinary shares and/or warrants to purchase an additional 5,799,108 ordinary shares on the same terms and conditions. The offering is expected to close on or about November 20, 2018, subject to customary closing conditions.

ReWalk expects to receive aggregate gross proceeds of approximately \$11.6 million from the offering, assuming no exercise of the underwriters' option to purchase additional securities. ReWalk intends to use the net proceeds from the offering for (i) sales, marketing and reimbursement expenses related to market development activities and broadening third-party payor coverage, (ii) research and development costs related to developing its lightweight "soft suit" exoskeleton technology for various lower limb disabilities, including stroke and other indications affecting the ability to walk, and (iii) the repayment of certain outstanding indebtedness and other related payments to Kreos Capital V (Expert Fund) Limited (approximately \$3.6 million in total, including principal, accrued interest and "end of loan" payments).

The offering is being made under an effective registration statement on Form S-1 filed with the Securities and Exchange Commission (the "SEC"). The offering is being made only by means of a prospectus forming part of the effective registration statement.
